Subject: Placement of PG Masters as I/C Lecturers in the discipline of Bio-Technology.

Government Order No. 08-Edu of 2017

Whereas, *vide* Government Order No.399-Edu of 2016, dated 18.10.2016, 03 (Three) PG Teachers have been elevated as I/C Lecturers in the discipline of Bio-technology; and

Whereas, the elevation of Mr. Firdous Ahmad Khan, appearing at Seniority No.18, to the post of I/C Lecturer (Bio-Technology) had been withheld for not taking permission of the Competent Authority for pursuing PG course; and

Whereas, Sh. Firdous Ahmad Khan submitted a representation to the Administrative Department, stating therein that he had sought permission from ZEO concerned for pursuing PG course, for which he had also been granted Extraordinary Leave without pay; and

Whereas, the School Education Department, after examining the matter in detail, has decided to accord post-facto permission in his favour and clear him for elevation as I/C Lecturer in the discipline of Bio-Technology.

Now, therefore, post-facto permission is accorded in favour of Mr. Firdous Ahmad Khan, PG Teacher for the period he pursued PG degree, with Extraordinary leave without pay, through regular mode from HNB Garhwal University, Uttarakhand.

Subsequently, on the basis of seniority/eligibility, Mr. Firdous Ahmad Khan, PG Teacher, whose service particulars are given herein below, is hereby placed as I/C Lecturer in the discipline of **Bio-Technology** in his own pay and grade, with benefit of charge allowance as admissible under rules, for a period of six months or till the posts are filled up, on regular basis, whichever is earlier:

The placement, however, shall not confer any superior claim or right upon him at the time of his confirmation and shall also be subject to the outcome of any court case that may be *sub judice* in the court(s) of Law.

The I/C Lecturer shall report to Directorate of School Education, Kashmir, within 21 days from the date of issuance of this order. If he fails to join within the stipulated period of time, it shall be presumed that he has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir, will allow him to join only after verifying the following:

- (i) The bio-data/ service particulars of the promotee as mentioned.

- (ii) The in-service candidates who have acquired P.G Degree are required to avail the leave during their service and after obtaining proper permission from the Competent Authority. In case during this verification, it is proved that he has failed to obtain the permission from the Competent Authority or he had not availed proper leave/deputation, his officiating placement shall be deemed to have been cancelled *ab initio* without any further notice. Director School Education, Kashmir, shall immediately revert him to his original place of posting.
- (iii) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of PG certificates/institutions from which he has acquired such degree are valid, shall be determined by the Directorate of School Education, Kashmir.
- (iv) The officer is not involved in any adverse case(s) (Vigilance/Crime etc), which fact shall be ascertained by the Directorate of School Education, Kashmir.
- (v) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vi) That the in-service candidate who has done projects during the period he has acquired degree certificate has obtained leave, otherwise salary for the aforesaid period shall be deducted from the salary of concerned incumbent.

The Directorate of School Education, Kashmir, shall ensure that all the above conditions are fulfilled by the above promotee before he actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the promotee, will not be allowed to join and his case shall be referred to the Administrative Department for further action.


