Subject: Placement of PG Masters as I/C Lecturers in the discipline of Botany.

Government Order No. 09-Edu of 2017

Whereas, *vide* Government Order No.583-Edu of 2015, dated 30.10.2015, 59 PG Masters have been elevated as I/C Lecturers in the discipline of Botany; and

Whereas, the elevation of following two PG Masters to the post of I/C Lecturers (Botany) had been kept withheld for the reasons shown below:

S. No.	Name S/Sh	Reason
1	Mohammad Yousuf Parray	Drawl of salary of Rs. 37,559/- during the period he was on the rolls of University for acquiring PG without due sanction
2	Fayaz Ahmad Andrabi	Permission along with leave without pay for acquiring PG which was not granted by the competent authority

Whereas, the cases of the aforesaid PG Masters were examined in the Department and Memorandum, Article of Charges and Statement of Imputation were served upon both of them through Directorate of School Education, Kashmir, on 24.10.2016, for explaining their position within 21 days; and

Whereas, the PG Masters replied to the charge-sheets served upon them explaining their position in the matter; and

Whereas, the School Education Department, after examining the matter in detail, has decided to release their elevation after according post-facto:

- i) permission for acquiring PG through University of Kashmir through regular mode in favour of Sh. Fayaz Ahmad Andrabi, PG Master, &
- ii) sanction to the Extraordinary Leave without pay in favour of Mohammad Yousuf Parray, PG Master, for the period he remained on the rolls of University of Kashmir for acquiring PG degree through regular mode.

Now, therefore, post facto permission for acquiring PG through University of Kashmir through regular mode is hereby accorded in favour of Sh. Fayaz Ahmad Andrabi, PG Master. Sanction is also accorded to the Extraordinary Leave without pay in favour of Mohammad Yousuf Parray, PG

Master, for the period he remained on the rolls of University of Kashmir for acquiring PG degree through regular mode.

Subsequently, on the basis of seniority/eligibility, the following two (2) PG Masters are hereby placed as I/C Lecturers in the discipline of **Botany** in their own pay and grade, with benefit of charge allowance as admissible under rules, for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be *sub judice* in the court(s) of Law.

The I/C Lecturers shall report to Directorate of School Education, Kashmir, within 21 days from the date of issuance of this order. If any of the I/C Lecturer(s) fails to join within the stipulated period of time, it shall be presumed that he has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir, will allow them to join only after verifying the following:

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**Botany**).
- (iii) The in-service candidates who have acquired P.G Degree are required to avail the leave during their service and after obtaining proper permission from the Competent Authority. In case during this verification, it is proved that they have failed to obtain the permission from the Competent Authority or they had not availed proper leave/deputation, their officiating placement shall be deemed to have been cancelled *ab initio* without any further notice. Director School Education, Kashmir, shall immediately revert him to his original place of posting.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of PG certificates/institutions from which he has acquired such degree are valid, shall be determined by the Directorate of School Education, Kashmir.
- (v) The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc), which fact shall be ascertained by the Directorate of School Education, Kashmir.
- (vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vii) That the in-service candidates who have done projects during the period they have acquired degree certificate have obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The Directorate of School Education, Kashmir, shall ensure that all the above conditions are fulfilled by the above promotees before he actually joins

in the Directorate. If any of the above mentioned conditions is not fulfilled by the promotee, he will not be allowed to join and such cases shall be referred to the Administrative Department for further action.
