Sanction is hereby accorded to the temporary appointment of Mtr. Fatima Banoo W/o late Ghulam Nabi (Ex-teacher) R/o Loundri Tehsil Drabshalla District Kisthwar, as Class-IV, in the pay scale of Rs.4400-74400 plus grade pay of Rs.1300/- in the School Education Department in District Cadre, Kishtwar, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Kishtwar within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

1. Age and Academic qualification Certificates.
2. Permanent Resident Certificate.
3. Character and antecedent's Certificates
4. No Demand Certificate from DIC & Employment Exchange
5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled Ab-Initio.

The appointee shall be on probation for a period of two years. The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Kishtwar.
