The above Promotion of Sr. lecturers shall be subject to outcome of writ petition(s) pending, if any, before the competent court(s) of law.

The Promotion of above Sr. lecturers is further subject to following conditions.

*L. T. Srinivasan*

1. The promotes shall report to their new place of posting within 21 days from the date of issuance of the order and in case of failure of any promote to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
2. They shall get promotion benefits only after getting clearance from GAD(vigilance) and in case adverse report is received from ACB, the promotes shall have no right to claim his/her appointment as +2 Principal and his/her appointment as such shall be deemed to have been cancelled ab-initio without further notice.
3. The officers shall submit an undertaking to the concerned CEOs stating that in case his/her service particulars/PG degree is found fake/forged/tempered or issued by an unrecognised university or the course is proved unrecognised at any stage, he/she shall have no claim on the appointment and the appointment shall be cancelled ab-initio without further notice.
4. The promotion benefits shall not be given to any officer unless the satisfactory reports in respect of (2) and (3) above are received in his/her favour.
