Sanction is accorded to the transfer of funds on account of uniform charges into the bank account of students/ parents @Rs 600/- per eligible student through DBT (Direct Benefit Transfer) mode during the financial year 2021-22 as per the guidelines of Samagra Shiksha. In order to ensure uniformity and quality of uniforms to be purchased by parents for their children (eligible students) following norms/ specifications are to be adhered to:-

- A. **Eligibility:-**All girls, SC, ST & BPL boys of class 1<sup>st</sup> to 8<sup>th</sup>
