The candidate shall be on probation for a period of two years.

The Office where the appointee is presently posted shall allow him to formally join on the post on which he has been regularized only after checking the following certificates in original:-

1. Date of Birth Certificate
2. Permanent Residence Certificate (PRC)
3. Academic Qualification Certificate
4. Technical Qualification Certificate
5. Character/antecedents verified from CID (J&K Police) required.
6. No Objection certificate from DIC/Employment Exchange.
7. That the appointee has not been selected by any Recruiting Agency/or appointed in any other Government Department.
8. That the allowance other than what was admissible/due has not been drawn.

9. That the employee is working against clear vacancy/post and has not been conveyed/recommended earlier by the Empowered Committee.

The order of regularization shall be subject to the cancellation ab-initio, in case, at any stage it emerges that the certificates/documents furnished by the appointee are fake/fictitious.
