Whereas, an inquiry under Rule 31 of Civil Services (Classification, Control and Appeal) Rules, 1956, is being conducted against the officers/officials involved in financial irregularities made by them in SSA funds for Civil works construction in Zone-Dangerpora in Baramulla District.

Whereas, charge-sheets were served upon the charged officials/officers *vide* No.Edu/Plan-SE/894/2013-14 dated 27.12.2016, and

Whereas, upon the examination of reply to the Article of Charges submitted by the charged officials/officers, the Government considers that an Inquiry Officer should be appointed to enquire into the charges framed against them.

Now, therefore, in exercise of powers conferred by sub-rule (4) of Rule 33 Civil Services (Classification, Control and Appeal) Rules, 1956, the Government hereby appoints Mr. Abid Hussain, KAS, Jt. Dir. (South), Directorate of School Education, Kashmir., as Inquiry Officer, to enquire into the charges framed against officers/officials involved in financial irregularities made by them in SSA funds for Civil works construction in Zone-Dangerpora in Baramulla District. Sh. Sanjay Pandita, Under Secretary to Government, shall be the Presenting Officer.

The Inquiry Officer shall complete the enquiry and submit report to the Administrative Department within 21 days positively from the date of issuance of this order.
