**Subject:-** Re-instatement of Shri Mohammad Yousuf Lone, Principal.

**Government Order No.** 174- Edu of 2017

**Dated:** 17 .04.2017

Whereas, complaints of misappropriation of funds and misuse of official position were received by the District Development Commissioner, Kupwara against Shri Mohammad Yousuf Lone, the then Principal, Government Higher Secondary School, Sogam and the officer was placed under suspension on 6.8.2015 by Deputy Commissioner, Kupwara; and

Whereas, a preliminary enquiry in the matter was conducted by the then District Social Welfare Officer, Kupwara; and

Whereas, the officer was re-instated by the Director School Education vide his order No. 14-DSEK of 2016 dated 08.1.2016; and

Whereas, charge sheet was served upon Shri Mohammad Yousuf Lone, the then Principal, Government Higher Secondary School, Sogam by the Director School Education vide his No. DSEK/IMW/Kup/24/2016/30 dated 3.10.2016 detailing therein the charges against the officer. Subsequently, order of revocation of suspension was withdrawn by the Director School Education, Kashmir vide his order No. 1397-DSEK of 2016 dated 6.10.2016 on the ground of having been issued without jurisdiction; and

Whereas, the reply of the charge sheet submitted by the officer has been examined along with the report of the Director School Education, Kashmir and it has been observed that the officer has committed financial impropriety but to a limited extent and has also failed to obtain approval of the competent authority prior to issuance of engagement orders on academic arrangement basis; and

Whereas, the matter was considered by the administrative department and considering impending retirement of the officer, it has been decided to take a lenient view in the matter and re-instate the officer with a warning to remain careful in future with the rider that the officer shall be given a non-sensitive posting.

Now, therefore, Shri Mohammad Yousuf Lone, the then Principal, HSS Sogam, is hereby re-instated with immediate effect. The officer is warned to remain careful in future. The period of suspension shall be decided separately. The officer shall await orders of further posting in the Directorate of School Education, Kashmir.
