Sanction is hereby accorded to the temporary appointment of Mst. Saira Begum W/o Late Mr. Aftab Ahmad Mir (Ex-Teacher) R/o Village Nagar Tehsil Bhaderwah, District Doda, as Class -IV, in the pay scale of Rs.4440-7440 with the grade pay of Rs. 1300/- in the School Education Department in District Cadre, Doda in relaxation of prescribed age in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Doda within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

1. Age and Academic qualification certificate.
2. Permanent Resident Certificate.
3. Character antecedent's certificate.
4. No Demand certificate from DIC & Employment Exchange
5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of police, CID, to whom a reference shall be made by the Chief Education Officer, Doda.
