Sanction is accorded to the advance drawal of Rs. 192,46,10,664/- (Rupees One hundred Ninety two Crores forty six lac ten thousand six hundred sixty four only) by the Financial Advisor / CAO, School Education Department for further placement of the same at the disposal of State Project Director, SSA under SSA 2nd installment as communited liability on account of teachers salary sanctioned by Ministry of Human Resource Development, Government of India, for implementation of SSA Schemes during the year 2016-17 as per the following details.

The expenditure of advance drawal shall be subject to the following conditions:-

- 1. The funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOIs prescribed guide lines.
- No diversion of funds is allowed and expenditure be booked as per the laid down norms/guidelines of SSA.
- 3. All the codal formalities are completed before incurring any expenditure.
- 4. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- 5. The Department shall send utilization certificates of the funds released as early as possible and definitely well before 31-03-2017 to Government of India with a copy to Finance Department / Administrative
- 6. The accounts of the society shall be open to check by the Accountant General/Finance Department as well as the officers of School Education Department at any time.
- 7. That the Red Account of the previous drawals and current sanctioned amount is furnished to the Accountant General at an appropriate time.
- 8. Accounts Officer of the SSA shall vouch safe the utilization of funds as per Codal procedure / Government of India's guidelines.
