2. Permanent Resident Certificate.
3. Character and antecedents certificate.
4. No Demand Certificate from DIC & Employment Exchange.
5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of his character and antecedents is

received from Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Ganderbal.
