**Sub: Fixing of criteria for granting award to meritorious students.**

**GOVERNMENT Order No: 27 -Edu of 2018**

**Dated: 08 - 01-2018**

In order to encourage meritorious students enrolled in Government Schools of the State, sanction is hereby accorded to the following criteria for conferring awards amongst students in recognition of their outstanding performance in examinations conducted by J&K State Board of School Education (J&K BOSE).

1. The award shall be given to meritorious students on the basis of their performance in examinations for Class 12<sup>th</sup> and 10<sup>th</sup> respectively, conducted by J&K BOSE in the previous year / session.
2. The award shall also carry cash payment, which shall be made to the students through Director Benefit Transfer (DBT) Mode. The meritorious students of Class 12<sup>th</sup> and 10<sup>th</sup> selected for such award shall be given cash prize of Rs. 15,000/- and Rs. 10,000/- each respectively.
3. Directors of School Education, Kashmir / Jammu shall recommend the names of 200 meritorious students, 100 each from Class 12<sup>th</sup> and Class 10<sup>th</sup>, in order of merit, along with their marks certificates.

The Directors of School Education, Kashmir / Jammu, should forward the information to the Administrative Department, on the basis of aforesaid criteria as per the enclosed proforma.
