**Subject: Placement of PG Masters as I/C Lecturer in the discipline of Zoology.**

Whereas, *vide* Government Order No.585-Edu of 2015, dated 30.10.2015, 40 PC Masters/Teachers have been elevated as I/C Lecturers in the discipline of **Zoology**; and

Whereas, the elevation of below-mentioned PG Masters to the post of I/C Lecturer (Zoology) had been kept withheld for the reason shown below:

1.	Bashir Ahmad Sofi,	Permission/ leave not taken
2.	Mohammad Farooq Malik,	Permission granted by ZEO, not the competent authority

Whereas, the case of aforesaid PG Masters was examined in the Department and Memorandum, Article of Charges and Statement of Imputation, were served upon them through Directorate of School Education, Kashmir on 24.10.2016, for explaining their position within 21 days; and

Whereas, the PG Masters replied to the charge-sheets served upon them explaining their position in the matter; and

Whereas, the School Education Department, after examining the matter in detail, has decided to release their elevation after granting post facto:

- permission for acquiring PG through regular mode in favour of Mr. Bashir Ahmad Sofi from SMU, Kanpur, and in respect of Mr. Mohammad Farooq Malik from University of Kashmir,
- sanction for Extraordinary Leave without pay in favour of Mr. Bashir Ahmad Sofi and Mr. Mohammad Farooq Malik, for the period they remained on the rolls of the concerned Universities for acquiring PG Degree through regular mode, and accordingly orders so.

As a consequence, on the basis of seniority/ eligibility, the officials are hereby placed as I/C Lecturers in the discipline of **Zoology** in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier:
