Subject: Placement of I/C Chief Education Officers & equivalent as I/C Joint Directors and equivalent – transfers & postings/adjustments thereof.

Pending clearance by the Departmental Promotion Committee/PSC, the following I/C Chief Education Officers & equivalent are placed as I/C Joint Directors and equivalent, in their own pay and grade, for a period of six months or till the posts are filled up on regular basis, whichever is earlier: -

The placements shall also be subject to the outcome of writ petition(s), pending if any, before any competent Court(s) of law. The superior claim of the officials, if any, shall be considered by demoting the junior officials.

The placement of Mr. Om Parkash (SC) as I/C Joint Director shall also be subject to vigilance clearance.
