Subject:- Transfers/postings of Lecturers to districts of Leh and Kargil.

Government Order No. 379-Edu of 2016

D a t e d : 30 .09. 2016

Sanction is hereby accorded to the transfer/ postings of 22 Lecturers to districts of Leh and Kargil, as indicated in **Annexure "A"** to this order, against available vacancies.

While affecting such transfers, due care has been taken that these are in accordance with Transfer Policy for Leh/Kargil Districts issued vide Government Order No. 20-LA of 1999 dated 16.06.1999 read with amendments thereafter, and the junior most promotees/direct recruits are posted to Leh/Kargil.

These transfers/postings are further subject to the following conditions:-

- a) The concerned HOD(s)/Principal(s) shall relieve the transferee within 03 days, failing which the transferee shall be deemed to have been relieved. They should join their new place of posting within the stipulated period, otherwise, action under rules shall be taken against those who fail to do so, without any further notice;
- b) The Controlling Officers/ DDOs shall strictly comply with Government Order No: 327-Edu of 2015 dated 10.07.2015
- c) The present DDOs shall not draw the salary of the transferee henceforth. Any departure from the same would be treated as dereliction of duty on the part of DDO concerned, making him liable to disciplinary action.
- d) The order is issued and transfers effected irrespective of any interim adjustment order issued by the Director School Education, Kashmir/Jammu, consequent upon placement of the official as I/C Lecturer in their respective discipline.

Sanction is also accorded to the travel by air in favour of the transferees.


