Whereas, an inquiry under Rule 31 of Civil Services (Classification, Control and Appeal) Rules, 1956, is being conducted against Sh. Ghulam Rabani Deedad, the then Warden, Gujjar & Bakerwal Hostel, Kupwara, for his involvement in official misconduct and gross financial irregularities, in his capacity as Warden, Gujjar & Bakerwal Hostel, Kupwara; and

Whereas, charge-sheets were served upon the charged officer *vide* No.Edu/Gaz-III/44/2016 dated 12.01.2017; and

Whereas, upon the examination of reply to the Article of Charges submitted by the charged officer, the Government considers that an Inquiry Officer should be appointed to enquire into the charges framed against him.

Now, therefore, in exercise of powers conferred by sub-rule (4) of Rule 33 Civil Services (Classification, Control and Appeal) Rules, 1956, the Government hereby appoints Mr. Mehboob Hussain Dar, Principal, SIE, Kashmir, as Inquiry Officer, to enquire into the charges framed against the officer.

Sh. Sanjay Pandita, Under Secretary to the Government, shall be the Presenting Officer.

The Inquiry Officer shall complete the enquiry and submit report to the Administrative Department within 21 days positively from the date of issuance of this order.


