**Sub: Authentication of DOB of Mtr. Hajra Begum, Ex-teacher.**

*Whereas*, Mtr. Hajra Begum, ex-teacher, joined the Government Service on 16-09-1966 with her date of birth recorded as 25-04-1950 in words as well as in figures on the first page of her service.

*Whereas*, there is an overwriting on the date of birth as 25.09.1950 recorded in the Service Book of the Ex-teacher.

*Whereas*, after her retirement on superannuation, the pension case of the said teacher was forwarded to the Principal Accountant General, J&K, Jammu for release of pension in her favour.

*Whereas*, the Principal, Accountant General, J&K, Jammu has returned the pension case of the ex-teacher for establishing her correct Date of Birth.

*Whereas*, the case was referred to the Chairman, Board of School Education for ascertaining the factual position with regard to the date of birth of the Ex-teacher.

*Whereas*, as per the Joint Secretary (Verification) of the J&K Board of School Education, Jammu vide his letter No: F (PS-JSV)/B/JD/2015 dated 16.01.2016 has communicated a copy of admission form of the candidate mentioning the date of birth of the official as 25.09.1950.

*Whereas*, as per the duplicate copy of School Leaving Certificate last attended by Mtr. Hajra Begum, ex-teacher, issued by the Principal Govt. Girls Higher Secondary School Thanna Mandi, Rajouri under the S.No. 586 bearing roll No. 94 for the session 1966 and countersigned by the concerned Chief Education Officer, the date of birth of the Ex-teacher is 25.09.1950.

*Whereas*, after examining the case in the Administrative Department, it has been found that on the basis of the verification carried out by the J&K BOSE and on the basis of the school leaving certificate last attended by the candidate issued by the Principal Govt. Girls Higher Secondary School, Thanna Mandi, Rajouri, and duly countersigned by the concerned Chief Education Officer, the actual date of birth of the Ex-official namely Mtr, Hajra Begum is 25.09.1950 (Twenty fifth of September, nineteen hundred fifty).

Now, therefore in pursuance of the article 6.4 of Financial Code Vol-1 read with article 35-AA of J&K Civil Service Rules Vol-1, sanction is accorded to the adoption of date of birth of Mtr. Hajra Begum, Ex-teacher as 25.09.1950.
