Sanction is hereby accorded to the temporary appointment of Mtr. Shahmal Begum W/o Late Fayaz Ahmad (Ex-Teacher) R/o Bhimadasa, Tehsil and District Ramban, as Class -IV, in the Pay Band of Rs.4440-7440 with Grade Pay of Rs. 1300/- in the School Education Department, in District Cadre Ramban, in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Ramban within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:

1. Age and Academic qualification certificate.
2. Permanent Resident Certificate.
3. Character and antecedent's Certificate.
4. No Demand certificate from DIC & Employment Exchange.
5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.


