Whereas, a final seniority list of PG Masters/Teachers in the discipline of Environmental Science was issued vide Government Order No. 435-Edu of 2015 dated 25.08.2015; and

Whereas, Mtr Shaheena Nazir, Teacher, BHSS Soura was figuring at Seniority No. 75 in the said final seniority list of EVS was also placed as I/C Lecturer (EVS) vide Government Order No. 433-Edu of 2015 dated 27.08.2015; and

Whereas, after issuance of the placement order, it has come to notice of the department that Mtr Shaheena Nazir has acquired her PG in Aquatic Environmental Science on regular basis instead of Environmental Science from Barkatullah Vishwavidyala, Bhopal ; and

Whereas, there is no specific guidelines with regard to the equivalence of PG degree in Aquatic Environmental Science with the PG degree in Environmental Science; and

Whereas, the issue of equivalence of MSc Environmental Science with MSc Aquatic Environmental Science requires further examination in the department in consultation with the University of Jammu and University of Kashmir; and

Whereas, till settlement of this issue of equivalence, the placement of Mtr Shaheena Nazir will be violation of the Recruitment Rules; and

Now, therefore placement of Mtr. Shaheena Nazir as I/C Lecturer in Environmental Science is kept in abeyance till further order. Consequent upon the above, the official shall report to CEO, Srinagar for further duties as General line Teacher..
