Shokat Ali (Ex Teacher) R/o Basantgarh, Tehsil Ramnagar, District Udhampur as Lab Assistant, in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs.1900/- in the School Education Department in District Cadre, Udhampur in School Education, Department.

The appointee shall report to the Chief Education Officer, Udhampur within a period of 21 days from the date of issuance of this order and he shall be allowed to join only after production of the following certificates/documents in original:-

1. Age and academic qualification certificate.
2. Permanent Resident Certificate.
3. Character and antecedent Certificate.
4. No Demand certificate from DIC & Employment Exchange.
5. Category Certificate, if any

However, if on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio. The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of his character and antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Udhampur.
