- All codal formalities shall be observed while incurring expenditure;

- No diversion/re-appropriation of the funds is allowed at any level;
- Drawing & Disbursing Officer/ implementing agency shall satisfy themselves about the reasonability of costs, proper quality control, and genuineness of work done claims and physical existence of works;
- The funds so released shall be utilized for the specified purpose after completing all the codal formalities/procedures as required under rules and shall not be available for re-appropriation/diversion at any level;
- The expenditure on this account shall be booked under proper head of account;
- Department shall ensure that works are taken up and completed within the approved cost only. No work shall be tendered/allotted beyond approved allocation. No cost escalation is allowed under the programme;
- There shall be no overlapping of funding from any other source such as SDRF/District Plan/CSS/Flagship Programme or any other source;
- Utilization certificate/ Red Accounts shall be furnished to concerned quarters including Accountant General J&K;
- Chief Account Officer/ Account Officer as the case may be shall vouchsafe the availability of funds under relevant head of account;
- That other terms and conditions stipulated in the authorization of Planning Development & Monitoring Department and School Education Department shall be adhered to in letter & spirit and funds utilized for the approved projects only which have prior Administrative Approval and Technical Sanction;
