The placement, however, shall not confer any superior claim or right upon him at the time of his confirmation and shall also be subject to the outcome of any court case that may be subjudice in the court(s) of Law.

The I/C Lecturer shall report to concerned Directorate of respective division for further posting/ adjustment within 21 days from the date of issuance of this order. The I/C Lecturer if fails to join within the stipulated period of time, it shall be presumed that he has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow him to join only after verifying the conditions as stipulated in Government Order No. 583-Edu of 2015 dated 30-10-2015.

The concerned Directorate of School Education Department shall ensure that all the conditions are fulfilled by an Official before he actually joins in the Directorate. If any of the conditions is not fulfilled by the Official, he will not be allowed to join and the case shall be referred to Administrative Department for further action.
