Sanction is hereby accorded to the advance drawal of **Rs. 1667.48 Lac (Rupees Sixteen Crore sixty seven lac forty eight thousand only)** by Financial Advisor / CAO, School Education Department as 'Grant-in-Aid' from Revenue Account under RMSA for further placement of the same at the disposal of State Project Director, RMSA for utilization during the year 2016-17.

**The expenditure of advance drawal shall be subject to the following conditions:-**

1. Expenditure be incurred as per the laid down guidelines by the Government of India.
2. No diversion of funds is allowed and expenditure be booked as per the laid down norms / guidelines of RMSA.
3. All the codal formalities are completed before incurring any expenditure.
4. The Department shall send utilization certificates of the funds released at the earliest to the Government of India with a copy to the Finance Department and Administrative Department.
5. The accounts of the Society shall be open to check by the Accountant General / Finance Department as well as the officers of School Education Department at any time.
6. That the Utilization Certificates of the previous drawals and current sanctioned amount is furnished to the Accountant General well in time.
7. Chief Accounts Officer of the RMSA shall vouch safe the utilization of funds as per Codal procedure / Government of India's guidelines.
