**Subject: Placement of PG Master as I/C Lecturer in the discipline of Zoology**

**Government Order No. 84 – Edu of 2017**

**D a t e d: 03 .03. 2017**

Whereas, *vide* Government Order No. 585-Edu of 2015, dated 30.10.2015, 40 PG Masters/Teachers have been elevated as I/C Lecturers in the discipline of Zoology; and

Whereas, the elevation of Mr. Shabir Ahmad Rather, Master, figuring at seniority No.55 of the updated/ final seniority list, was kept withheld for the reason that he had obtained permission from concerned Headmaster, who was not the competent authority for grant of such permission; and

Whereas, Director School Education Kashmir *vide* his letter No. DSEK/PGMT-PF/198 dated 07.10.2015 has again verified the service particulars, among others, in respect of Mr. Shabir Ahmad Rather, Master, stating therein that the permission has been granted by the Headmaster, as also 40 days HPL and 53 days leave without pay; and

Whereas, the School Education Department, after examining the matter in detail, has decided to release his elevation after according *post facto*

- i. Permission for acquiring PG through regular mode in favour of Mr. Shabir Ahmad Rather, Master from University of Kashmir.
- ii. Sanction to the grant of Extraordinary Leave without pay in favour of Mr. Shabir Ahmad Rather, Master from University of Kashmir, for the period he remained on leave for acquiring PG Degree through regular mode.

As a consequence, on the basis of seniority/ eligibility, Mr. Shabir Ahmad Rather, Master, whose service particulars are given below, is hereby placed as I/C Lecturer in the discipline of **Zoology**, in his own pay and grade with charge allowance as admissible under rules for a period of six months or till the post is filled up on regular basis, whichever is earlier:-

The placement, however, shall not confer any superior claim or right upon him at the time of his confirmation and shall also be subject to the outcome of any court case that may be *sub-judice* in the court(s) of Law.

The I/C Lecturer shall report to Directorate of School Education, Kashmir, within 21 days from the date of issuance of this order. If he fails to join within the stipulated period of time, it shall be presumed that he has foregone the elevation and his placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir will allow him to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotee as mentioned.

- (ii) The promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (Zoology).
- (iii) The in-service candidates who have acquired P.G Degree are required to avail leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave/ deputation, their officiating placement shall be deemed to have been cancelled *ab-initio* without any further notice. The Director School Education shall immediately revert him to his/ her original place of posting.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which he has acquired such degree are valid, shall be determined by the Directorate of School Education, Kashmir.
- (v) The officer is not involved in any adverse case(s) (Vigilance/Crime etc.) which fact shall be ascertained by the Directorate of School Education, Kashmir.
- (vi) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.
- (vii) That the in-service candidate who has done projects during the period he has acquired degree certificates has obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The Directorate of School Education, Kashmir shall ensure that all the above conditions are fulfilled by the above promotee before he actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he will not be allowed to join and his case shall be referred to the Administrative Department for further action.
