These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be subjudice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions for further posting/ adjustment within 21 days from the date of issuance of this order. Any I/C Lecturer who fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow them to join only after verifying the conditions as stipulated in Government Order No. 585-Edu of 2015 dated 30.10.2015.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by an Official before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by an Official, he/she will not be allowed to joins and such cases shall be referred to Administrative Department for further action.
