Subject : - Placement of Principal & equivalent as I/C Chief Education Officers & equivalent. Transfers / postings thereof.

Whereas, among others Shri Pardeep Kumar was elevated under RBA category as I/C Chief Education Officer & equivalent and posted as I/C Field Advisor, SIE, Srinagar vide Government Order No. 300-Edu of 2012 daetd 22-03-2012;

Whereas, among other things the order states that the superior claim shall be considered by demoting the junior one;

Whereas, Shri Krishan Lal Parihar (RBA), Principal, HSS Mohalla, Doda (figuring at S. No. 426 in the seniority list of +2 School Principals) represented for his placement as I/C Chief Education Officer & equivalent on the basis of B.Ed as his junior Shri Pardeep Kumar has been placed as I/C Chief Education Officer & equivalent.

Whereas, Shri Pardeep Kumar is figuring at S. No. 482 in the Updated / final seniority list of +2 School Principals & equivalent and is junior to Shri Krishan Lal Parihar;

Whereas, the case of Shri Krishan Lal Parihar (RBA) has been examined and it has been found that B.Ed qualification of the said officer had not been indicated against his name in the updated / final seniority list of +2 School Principals & equivalent due to which he has not been considered for placement as I/C Chief Education Officer & equivalent;

Whereas, on the production of B.Ed certificate, Shri Krishan Lal Parihar is eligible for placement as I/C Chief Education Officer & equivalent against the post, Shri Pardeep Kumar was considered, as he is senior to Shri Pardeep Kumar;

Whereas, on the above mentioned facts, placement of Shri Pardeep Kumar (RBA) as I/C Chief Education Officer & equivalent needs to be withdrawn.

Now, therefore, it is hereby ordered that: -

- i. the placement of Shri pardeep Kumar (RBA) as I/C Chief Education Officer and equivalent ordered vide Government order No. 300-Edu of 2012 dated 22-03-2012 shall be deemed to have been withdrawn abinitio.
- ii. Shri Pardeep Kumar (RBA) is posted as Principal, HSS Panihad, Rajouri against available vacancy.


