The regularization is further subject to the following conditions:-

- i. The Drawing & Disbursing Officers shall take an undertaking from the concerned Officer in a shape of an affidavit duly attested by the 1st Class Magistrate to the effect that if his/her service particulars/PG Certificate is found fake/forged/tempered or issued by un-recognized University or the course is proved as un-recognized at a later stage, he /she shall have no claim for the regularization and the regularization order issued in his/her favour be treated as cancelled ab-initio without further notice.
- ii. The Drawing & Disbursing Officers concerned will obtain LPC and other related details above from the Drawing & Disbursing Officers of their parent offices before fixing the pay of these Officers in the relevant pay scales as revised from time to time.

The Drawing & Disbursing Officers shall be responsible for implementation/fulfillment of above conditions in letter and spirit.
