In terms of Jammu and Kashmir (Compassionate Appointment) Rules, 1994, sanction is hereby accorded to the temporary appointment of Mr. Malik Faizan, S/o Mohd Ashraf Malik(deceased Teacher, UPS Lalgam), R/o Noorpora, Awantipora, District Pulwama, as **Laboratory Assistant**, in the Pay Scale of Rs. 5200-20200 with Grade Pay of Rs.1900/-, in the School Education Department, in District Cadre Pulwama.

The appointee shall report to the Chief Education Officer, **Pulwama**, within a period of 21 days from the date of issuance of this order and he shall be allowed to join only after production of the following certificates/documents in original:-

- 1. Academic qualification certificates.
- 2. Age and Health Certificate
- 3. Permanent Resident Certificate.
- 4. No Demand Certificate from DIC & Employment Department.
- 5. Category Certificate, if any

If on verification, the certificates produced by the appointee are proved fake, the appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report about the verification of his character and antecedents is received from Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, **Pulwama**.
