Subject: - Constitution of Project Implementing Agency (PIAs) for projects under JKIDFC.

Refer:- Government Order No: 495-FD of 2018 Dated: 20.11.2018 issued by the Finance Department under endorsement No.: FD/RES/2018-19/JKIDFC/165-804 dated: 20.11.2018.

Government Order No: 102 - Edu of 2019 Dated: 28.02.2019

Sanction is hereby accorded to the constitution of Project Implementing Agency (PIA) in the School Education Department for implementation/completion of the languishing/unfunded projects under JKIDFC, duly approved by the High Power Committee with the following composition:-

- i) Director Finance, School Education Department.
- ii) Deputy Director/ Assistant Director (Planning) School Education Department.

The role and responsibilities of PIA would be as under:-

a) Director Finance, School Education Department:-

- i) shall open an escrow account in J&K Bank Moving Secretariat Branch forthwith;
- ii) shall execute a tripartite agreement with Executive Director/Director Finance JKIDFC Ltd and the concerned Bank branch for operationalization of the escrow account;
- iii) shall strictly ensure that the payments are credited to the account of the contractor/implementing agency/vendor/claimant as the case may be, directly through Direct Benefit Transfer (DBT).

b) Deputy Director/Assistant Director Planning, School Education Department:-

- shall obtain duly vetted claims from Director School Education Jammu/Kashmir and State Project Director Samagra Shiksha as the case may be and make available to the Director Finance, School Education Department for settlement of payment dues through above defined mechanism in a time bound manner;
- shall ensure completion of basic requisite formalities before incurring of expenditure over any Languishing project out of funds provided through JKIDFC Ltd, and obtain a certificate as shown in Annexure-A to this Government Order from Director School Education Jammu/Kashmir and State Project Director Samagra Shiksha as thecase may be and submit the same to the Director Finance after counter signing by the Administrative Secretary;

iii) shall ensure that the respective Executive Engineer of the School Education Department uploads the information/photographs of the languishing projects on the Dash Board/Web Portal as per the calendar notified and monitor the execution of works with respect to date of completion of work.

Besides following further direction are issued to the field officers for strict compliance:-

- i) Director School Education Jammu/Kashmir and State Project Director Samagra Shiksha shall ensure timely completion of the identified Languishing/Unfunded projects within their respective jurisdictions funded by Jammu & Kashmir Infrastructure Development Finance Corporation (JKIDFC);
- ii) The respective Executive Engineer of the School Education Department shall be responsible for uploading of information/Photographs of the Languishing projects in their respective divisions including works executed by other agency viz PWD (R&B) etc on the Dash-Board/Web portal on fortnightly/monthly basis for monitoring of Languishing projects for which username and password shall be shared separately.

Director School Education Jammu/Kashmir and State Project Director Samagra Shiksha to give certificate of adherence of all below mentioned points:-

- 1. To ensure sanction of Administrative Approval accorded to the original/revised project cost of each concerned project.
- 2. To certify that the remaining part of the languishing projects is not being funded through any other source of funding.
- 3. That there is no land acquisition issue involved for the execution of the work.
- 4. That all the necessary clearances pertaining to Forest and Environment have been obtained from the concerned quarters, wherever required.
- 5. Original copy of DPR along with Technical Sanction and cost benefits ratio has been vetted by the competent authority.
- 6. Latitude and longitude coordinates of each location of the project and ensuring geo-tagging of all the languishing projects completed under this dispensation.
- 7. Uploading of Photographs before initiation and after completion of the work funded under this dispensation.
- 8. Project completion certificate duly signed by the head of the concerned Executing agency and Director School Education Jammu/Kashmir and State Project Director Samagra Shiksha as the case may be.
