Subject:- Cancellation of appointment of Mr. Imtiyaz Ahmad S/o Ghulam Hassan Wani R/o Griend Kallan Budgam as Lecturer 10+2 in the discipline of Political Science.

Government Order No. 1037-Edu of 2017 D a t e d. 22-12-2017

Whereas, Jammu and Kashmir Public Service Commission, vide communication No. PSC/DR/10+2 Pol.Science/2016, dated 19.07.2017, forwarded select list of candidates for the post of Lecturer 10+2 in the discipline of **Political Science** in School Education Department; and

Whereas, on the basis of recommendations of J&K Public Service Commission, 25 candidates were appointment as Lecturers 10+2 in the discipline of Political Science in the School Education Department vide Government Order No. 530-Edu of 2017 dated 10.08.2017; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within 21 days from the date of issuance of the order, failing which their appointment orders will be cancelled without any notice; and

Whereas, Mr. Imtiyaz Ahmad S/o Ghulam Hassan Wani R/o Griend Kallan Budgam figuring at S.No. 5 under RBA category in the appointment order issued vide Government Order No. 474-Edu of 2017 dated 25-07-2017, has failed to join in the Directorate of School Education, Kashmir within the stipulated time period; and

Whereas, Directorate of School Education, Kashmir had given final opportunity to the above candidate to join within a week's time positively by issuance of notice vide No. DIPK-6842/17, dated 28.09.2017, through print media in daily newspapers viz. "Greater Kashmir". However, he again failed to join in the Directorate of School Education, Kashmir; and

Whereas, due to non-joining of above mentioned candidate and after giving him final opportunity, his appointment as Lecturer 10+2 in the discipline of Political Science in the School Education Department is required to be cancelled and the Administrative Department is required to operate the waiting list of respective category.

Now, therefore, the appointment of the Mr. Imtiyaz Ahmad S/o Ghulam Hassan Wani R/o Griend Kallan Budgam figuring at S.No. 5 under RBA category as
