Subject: Transfers and postings of Principals, I/C Principals and equivalent.

In the interest of administration and in partial modification of Government Order No.1014-Edu of 2017, dated 16.12.2017, the following transfers and postings of Principals, I/C Principals and equivalent are hereby ordered with immediate effect:-

It is further ordered that:

- i. the names of I/C Principals and equivalent appearing at S.Nos. 29 & 30 in Government Order No. 1014-Edu of 2017, dated 16.12.2017 shall and shall always be deemed to have been deleted *abi nitio* from the said Government Order.
- ii. Mr. Mohammad Ibrahim, Sr. Lecturer, HSS Rohama, Baramulla shall look after the work assigned to Principal HSS, Rohama, Baramulla, on temporary basis, till a permanent arrangement is made by the Department to fill up the posts in terms of Recruitment Rules. This shall also relieve I/C Principal HSS Hadipora, Baramulla, of the additional charge of the post of Principal HSS Rohama, Baramulla.
- iii. CEO Kargil shall assign the look-after charge of the post of Principal, HSS Barsoo, Kargil to the senior-most Senior Lecturer of HSS Barsoo, Kargil, till a permanent arrangement is made by the Administrative Department to fill up the posts in terms of Recruitment Rules.

The temporary arrangement at (ii) & (iii) above shall, however, not confer any superior claim/ right upon the Sr. Lecturers at the time of regularization which shall be considered strictly in light of recruitment rules and seniority. This arrangement will also be reversible when the posts of Principals and equivalent will be filled up from the eligible officers.

Advance TE, as admissible under rules, is also sanctioned in favour of those officers in whose case change of station is involved.


