**Subject: Assigning of look-after charge of the posts of Zonal Education Officers & equivalent.**

**Ref:- Director School Education, Jammu's proposal No. DSEJ/Gaz/9492 dated.20.04.2020 and No.DSEJ/Gaz/9511 dated.21.04.2020.**

**Government Order No. 107-Edu of 2020  
Dated: 22.04.2020**

Whereas, the eligible officers were placed against vacant posts of Zonal Education Officer & equivalent falling under OM category, on officiating basis vide various Government Orders; and

Whereas, the number of posts of Zonal Education Officers & equivalent falling under various reserved categories in terms of reservation rules, could not be filled up on officiating capacity basis in view of the advisory from Law Department/General Administration Department vide O.M. No. LD (Opn) 2015/101-CS, dated.22.01.2016 read with GAD's O.M.No GAD/MTG/RB-IV/04/2016, dated.04.03.2016 on the strength of Apex Court directions; and

Whereas, these unfilled posts are of administrative nature and keeping these posts vacant would adversely affect the functioning of the Department and implementation of various Government Schemes; and

Whereas, it has been considered appropriate to fill these posts by assigning the charge to the officers from the feeding service in order of seniority and eligibility on look-after basis; and

Now, therefore, in view of the administrative exigencies, it is hereby ordered that the following officers shall look-after the posts of Zonal Education Officers & equivalent, indicated against each, till these posts are filled up on officiating or regular basis, whichever is earlier:-

This arrangement is purely temporary and interim arrangement and shall not confer any right upon these officers to claim seniority / placement / promotion/ regularization on these posts, which shall be strictly done as per rules and in order of seniority/availability of vacancy. The officers assigned the look-after charge shall not be entitled to charge allowance.

The concerned Chief Education Officer shall verify that there is no departmental inquiry/RDA/court/vigilance case pending against the officer and if on verification, anything adverse is found against him/her, same shall be immediately reported to Director, School Education, Jammu , who along with her recommendations shall bring the same to the notice of Administrative Department.

Director, School Education Jammu shall, within a period of 10 days, take immediate action for posting of Heads in the above office/Schools which are getting vacant. However, till that period, above i/c Headmasters/ZEPOs shall also simultaneously hold the charge of office/Schools where they are presently posted.

The above arrangement shall be without prejudice to the outcome of writ petition (s), if any, pending consideration before any competent Court(s) of law.
