With reverence and regards, we the villagers of upper Breng Block Larnoo want your good self to have your kind attention towards the following few points.

1. That the Zone Vailoo consists of 160 Govt Schools out of which 65 % schools are in Larnoo block.
2. That the pupil teacher ratio is not being maintained by the ZEO as the far-flung schools lack basic teacher ratio
3. That some far-flung schools in our block despite recruited strength are not being curated by maintenance of PTR
4. That teachers are being harassed unnecessarily by abusive remarks and defaming the integrity of the teachers
5. That some turn coats of the officer for their own benefit unduly misuse the sanctity of the office against the teacher
