Subject: Disengagement of services of Sh. Kuldeep Kumar, working on academic arrangement basis at Government Higher Secondary School, Keerian.

Whereas, Sh. Kuldeep Kumar, was engaged as Lecturer (English) purely on academic arrangement basis by Chief Education Officer, Kathua, at Government Higher Secondary School, Keerian, for the academic session 2016-17; and

Whereas, a complaint was lodged against him related to his conduct and an FIR No.222/2016 under Section 294 of RPC came to be registered in Police Post, Kathua, followed by framing of the charges by the competent court in its order dated 23.02.2017; and

Whereas, the Deputy Commissioner, Kathua, *vide* his reference No: DCK/Compt./2016-17/206-209 dated 14.03.2017, has directed his disengagement in view of the circumstances related to the case and apprehension of disturbance of public peace and tranquility; and

Whereas, during the examination of the instant matter it came to the notice of the Department that the Hon'ble High Court, in SWP No.222/2016 titled Rakhi and Ors V/State & Ors on 09.05.2016, has also directed that the person engaged on academic arrangement basis shall not be substituted by another arrangement of similar nature. The said order, however, has been passed in a different context, i.e. of engagement of persons on academic arrangement basis; and

Whereas, the matter has been considered in its entirety in the School Education Department and taking note of the serious allegation of moral turpitude as also framing of charges by the competent court and report of Deputy Commissioner, Kathua, it is the considered view of the Department that engagement of Sh. Kuldeep Kumar in a Higher Secondary School is not desirable; and

Now, therefore, Sh. Kuldeep Kumar, working on academic arrangement basis in Higher Secondary School, Keerian, is disengaged with immediate effect.

And consequent upon the above, Sh. Ram Krishan, presently posted as Lecturer (English) on substantive basis in Government Higher Secondary School (Boys), Kathua, is transferred and posted in GHSS, Keerian, against the available vacancy. He is deemed to have been relieved with immediate effect and is directed to report for further duties at his new place of posting, without availing any joining time.
