In continuation to Govt. Order No.63-Edu of 2015, Dated. 12-02-2015, sanction is hereby accorded to the advance drawal of Rs 19.00 Lacs (Rupees Nineteen Lacs only) in favour of Director School Education, Kashmir under the scheme "Direction & Administration" with the object head "Stipend/Scholarship (Bharat Darshan)" available in annual Plan 2014-15 (Revenue Component) for incurring expenditure on purchase of bus/railway tickets and other allied arrangements for the prospective touring of students/escorts/teachers. With the issuance of instant order advance drawal during the year for the said purpose would aggregate to Rs.38.00 lacs(Rupees Thirty eight lakhs only).The advance drawal is subject to the fulfilment of all codal formalities, procedural norms and following conditions:-

- 1) The amount of the advance drawal shall be utilized for the authorized purpose only.
- 2) Any savings out of the advance drawal occurring due to the reduction of the number of days/participants keeping in view the actual expenditure in accordance with the admissibility and reasonability or otherwise shall be refunded to the Government.
- 3) That no purchases other than related to the tour are made out of the said amount.
- 4) That the Red Account of the advance drawal is submitted to the Accountant General after conclusion of the tour.
- 5) Chief Accounts Officer, Director School Education, Kashmir shall vouchsafe the availability of funds.
- 6) The funds for the purpose are actually available in the current financial year under annual plan 2014-15.

The expenditure shall be debited to the major head 2202 (Revenue Component) Annual Plan 2014-15.
