Subject: - Release of Additionality as matching State Share (Capital Component) under National Programme for MDM in Schools during 2014-15

Sanction is hereby accorded to the release of an additionality of Rs 705.18 lakhs (Seven hundred five lakhs and eighteen thousand only) as matching State Share for the components of Cooking Cost and Honorarium to Cook cum-helpers, comprising Rs. 319.09 lakhs (Three hundred Nineteen lakhs and Nine thousand only) in favour of Director School Education Jammu and Rs. 386.09 lakhs (Three hundred Eighty Six lakhs and Nine thousand only) in favour of Director School Education Kashmir under capital component for implementation of National Programme for MDM in Schools during 2014-15.

The release of funds is subject to following terms and conditions:-

- 1. The funds shall be utilized for implementation of the scheme strictly as per the GOI's prescribed guidelines.
- 2. No diversion/re-appropriation of funds is allowed.
- 3. Funds shall be utilized after observing all codal formalities.
- 4. Director Finance, School Education shall vouchsafe the utilization of funds as per codal procedure/GOI's guidelines.
- 5. Utilization certificates shall be furnished in approved formats I-VII as stipulated in Para 7 of guidelines.
