The above placement is temporary and shall not confer any preferential right on the aforesaid officials to hold these posts on substantive basis or claim promotion, which shall be made in accordance with the extant rules in the DPC as per set procedure (*inconsonance with eligibility, seniority availability of vacancy and in light of Government Order No. 743 GAD of 2007 Dated: 28-06-2007*) and shall be subject to the outcome of the writ petition(s), if any pending, in the Court of Law.

Besides, the above placement is further subject to the following conditions:

- (i) The I/c Lecturers shall join their new place of postings within a period of 21 days from the date of issuance of this order, otherwise it shall be construed that they have foregone their new assignment and action as warranted under rules shall follow.
- (ii) The DDOs shall draw and disburse their salaries only after verification of Degrees from concerned quarters and after satisfying himself/herself regarding genuineness of PG Degrees in accordance with relevant Government Orders.
- (iii) The postings of the officials shall also remain subject to the condition that the Universities/Institutions from which they have obtained their degrees are recognized as per UGC guidelines and are DEC/AICTE approved.
- (iv) The candidates who have obtained PG degrees through Distance Mode are also under consideration for placement / promotion subject to the condition that they have obtained PG Degrees from universities accredited / approved by UGC / DEC / AICTE. Besides, clear-cut recommendations of the concerned Directors is required in light of Government Order No. 940 Edu of 2017 Dated: 17-11-2017. The degrees obtained from Distance Education Mode from Off-campus / study centers which have been

established by State universities beyond their territorial jurisdiction shall not be considered as per Government Order No. 252-HE of 2012 Dated: 30-05-2012.

- (v) The dropees of placement in 2019 who figure in the seniority list issued vide Government Order No. 105-Edu of 2020 Dated: 22-04-2020 and have obtained their PG Degrees (**in Commerce**) in distance mode are also under consideration for this new assignment/promotion in the DPC subject to genuineness of their PG Degrees in light of Government Order No. 940 Edu of 2017 Dated: 17-11-2017 and Government Order No. 252-HE of 2012 Dated: 30-05-2012 to be verified by the concerned Directors.


