Sunita Devi W/o Late Mr. Rohit Sharma (Ex-Teacher) R/o Village Neota, Tehsil Bhaderwah District Doda, as Class-IV, in the Pay Scale of Rs. 4440-7440 with the Grade Pay of Rs.1300/- in the School Education Department in District Cadre, Doda in relaxation of the prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Jammu within a period of 21 days from the date of issuance of this order and she shall be allowed to join only after production of the following certificates/documents in original:-

01. Age and Academic qualification certificate.
02. Permanent Resident Certificate.
03. Character antecedents certificate.
04. No Demand certificate from DIC & Employment exchange
05. Category Certificate, if any

However, if on verification, the certificate produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of her character and antecedents is received from Inspector General of police, CID to whom a reference shall be made by the Chief Education Officer, Doda.
