The appointee shall report to the Chief Education Officer, Jammu within a period of 21 days from the date of issuance of this order and he shall be allowed to join only after production of the following certificates/documents in original

- 01.Age and Academic qualification certificate.
- 02.Permanent Resident Certificate.
- 03.Character antecedents certificate.
- 04.No Demand certificate from DIC &Employment Exchange
- 05.Category Certificate, if any

However, if on verification, the certificate produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of his character and antecedents is received from Inspector General of police, CID to whom a reference shall be made by the Chief Education Officer, Jammu.
