Subject: Restriction for COVID containment- reg.

**Government Order No: 1437- JK(Edu) of 2021**  
**Dated: 17.9.2021**

In continuation of Government Order No: 1230-JK(Edu) of 2021 dated 02.8.2021, it is hereby ordered that all Government Educational Institutions including recognised Private Schools shall observe following:-

- i) In case of class 1<sup>st</sup> to 5<sup>th</sup> (primary stage), "Online synchronous learning be undertaken for three sessions of 30-45 minutes on each school day.
- ii) In case of class 6<sup>th</sup> to 8<sup>th</sup> (elementary stage) "Online synchronous learning be undertaken for four sessions of 30-45 minutes on each school day.
- iii) In case of class 9<sup>th</sup> to 12<sup>th</sup>, "Online synchronous learning be undertaken for not more than five sessions of 30-45 minutes on each school day.
- iv) All schools shall follow routine time table for classes 6<sup>th</sup> to 12<sup>th</sup> (blended learning) to ensure completion of prescribed syllabus well before annual examination.
- v) For class 10<sup>th</sup> and 12<sup>th</sup>, in-person teaching of students, instructions issued by Department of (DMRRR) J&K vide Government Order No. 67-JK(DMRRR) of 2021, dated 12-9-2021 shall be followed in letter and spirit by concerned HoSs.
- vi) Head of schools are permitted to conduct offline Pre-Board examinations for classes 10<sup>th</sup> and 12<sup>th</sup> session 2020-21.
- vii) JK SCERT & DIETs shall impart offline teacher trainings with restricted gathering to 25 persons.
- viii) Prescribed guidelines on digital education and COVID appropriate behavior shall be followed in letter and spirit.
