In continuation to G.O No: 464-Edu of 2021 dated 20.05.2021, G.O No:1147-Edu of 2021 dated 08.07.2021 and G.O No.1423-Edu of 2021 dated 14.09.2021, sanction is hereby accorded to the regularization of In-charge Principals/Sr. Lecturers/ZEOs as Principals & equivalent in School Education Department as mentioned in **Annexure "A" & "B"** to this Government order in the revised pay level 10-A (56600-179800) with effect from the dates indicated against each.

The regularization is without prejudice to the outcome of any writ petition pending in any Competent Court(s) of law or any case pending in Vigilance or Crime Branch.

The regularization is further subject to the following conditions:-

- i) The Drawing & Disbursing Officers shall take an undertaking from the concerned Officer in shape of an affidavit duly attested by the 1<sup>st</sup> Class Magistrate to the effect that if his/her service particulars/PG Certificate is found fake/forged/tempered or issued by un-recognized University or the course is proved as un-recognized at a later stage, he/she shall have no claim for the regularization and the regularization order issued in his/her favour be treated as cancelled ab-initio without further notice.
- ii) The Drawing & Disbursing Officers concerned will obtain LPC and other related details above from the Drawing & Disbursing Officer of their parent offices before fixing the pay of these Officers in the relevant pay scales as revised from time to time.

The Drawing & Disbursing Officers shall be responsible for implementation/fulfillment of above conditions in letter and spirit.






