Sanction is accorded to the transfer of funds on account of uniform charges into the bank account of students/parents @Rs 600/- per eligible student through DBT (Direct Benefit Transfer) mode for the financial year 2020-21 as per the guidelines of Samagra Shiksha. In order to ensure uniformity and quality of uniforms to be purchased by parents for their children (eligible students) following norms /specifications are to be adhered to:-

A. Eligibility:-All girls, SC, ST & BPL boys of class 1st to 8th
