Assigning of look after charge of the posts of Zonal Education Officers and equivalent to I/c Headmasters.

Government Order No./48) -Edu of 2021 Dated: 18 -10-2021

Whereas, a number of ZEO and equivalent posts are vacant in UT of J&K having adverse affect on monitoring, supervision of academics and accountability of staff in the Institutions especially at the elementary level and also on implementation of various Government Schemes.

Whereas, conducting DPC for promotion of Headmasters as ZEOs may take some time in view of updating seniority in the cadre, it has been considered appropriate to fill up these vacant posts by assigning the charge to the Officers from the feeding service on look after basis strictly as per seniority and eligibility.

Therefore, keeping in view the administrative exigencies and to infuse accountability at grass root level and without prejudice to the seniority of others and subject to any pending writ petition (s) in any Court of Law, following 35 I/C Headmasters are hereby assigned as look after charge of Zonal Education Officers & equivalent as shown against each, for a period of six months or till these posts are filled up on regular basis, whichever is earlier:

Besides, the Officers mentioned above shall exercise Drawing and Disbursing Powers in addition to their Administrative Powers.

The above assignment shall further be subject to the following conditions:

7. The officers shall report to the concerned CEOs within 21 days from the date of issuance of this order and in case of failure to join within the stipulated period, his/her placement shall be deemed to have been cancelled ab-inito without any further notice.

8. The Officers shall get promotion benefits only after being considered in DPC as per seniority, eligibility and accrual of substantive vacancy and other requisite conditions of DPC and after getting clearance from GAD (vigilance) and in case adverse report is received from ACB, he /she have no right to claim his/her placement as ZEO & equivalent his/her placement as such shall be deemed to have been cancelled ab-inito without further notice.

9. The Officer shall submit an undertaking to the concerned CEO stating that , in case his/her service particulars/ academic credentials are found fake/forged/tempered or issued by an unrecognised university or the course is proved unrecognised at any stage , he/she shall be personally responsible and shall have no claim on the placement and shall be cancelled ab-inito without any further notice.

Further, Shri Mohammad Latif look after ZEO Shadimarg Pulwama is ansferred and posted as look after ZEO Harni Poonch on medical grounds against an vailable vacancy. The DDO Powers of Zone Shadimarg Pulwama shall be vested with rincipal HSS Abhama, Pulwama till further orders.
