The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Pulwama.
