4. No Loan certificate under self-Employment Scheme from Industries/Employment Department.
5. Category certificate, if any.
6. Health Certificate.

The order of appointment shall be cancelled ab-initio, in case, at any stage it emerges that the certificates /documents furnished by the appointee are fake/fictitious.

The appointee shall be on probation for a period of two years.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character antecedents is received from Inspector General of Police, CID to whom a reference shall be made by the Chief Education Officer, Pulwama.
