As per recommendation of the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of the selected 13 candidates, as Class-IV in the District Cadre, Jammu, UT of Jammu & Kashmir in the Pay Level of SL1 (14800-47100) in the School Education Department. (List enclosed).

The above appointee(s) shall report to the office of the Chief Education Officer. **Jammu** within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate
- iii. Health certificate from the Chief Medical Officer of the District.
- iv. Domicile Certificate.
- v. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vi. Undertaking regarding no criminal records.

The appointment of the appointee(s) shall further be subject to the following conditions:

- I. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- II. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of qualification /other certificates are received from the concerned authority.

- All these appointments shall be made in terms of the Jammu and Kashmir III. Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17.6.2020.
- The cadres/Departments allocated by appointing authority/SSB shall not be IV. changed under any circumstances by any authority/Department.
- The appointments shall be cancelled abinitio, if it is found that the candidate is ν. having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- If the candidates fails to join within a period of twenty one (21) days from the VI. date of issuance of order they shall forgo right to appointment which shall be shall deemed to have been cancelled abinitio without any further notice.
- It will be in conformity with all norms/guidelines for recruitment/appointment VII. notified by the Govt.
- The inter-se seniority of the candidates shall be reckoned as per the merit VIII. furnished by the SSB
 - All the appointment orders shall be issued subject to outcome of any petition/(s) IX. pending in any competent court/Tribunal etc.
