Whereas, updated/final seniority list of PG Masters/Teachers in the discipline of English was issued vide Government Order No. 177-Edu of 2017 dated 18.04.2017; and

- 2. Whereas, on the basis of the final seniority list, placement orders in respect of 47 (forty seven) & 5 (five) PG Masters as I/C Lecturer in the discipline of English was issued vide Government Order No. 903-Edu of 2017 dated 26.10.2017 and Government Order No. 928-Edu of 2017,dated 14.11.2017 respectively; and
- 3. Whereas, following PG Masters have represented to this department along with requisite documents for their placement as I/C Lecturer, which was kept withheld for the reasons that they have not taken prior permission/requisite leave from the Competent Authority for acquiring P.G Degree:-

- 7. Whereas, it has also been decided to accord necessary ex-post facto sanction for grant of permission with Extra Ordinary Leave without pay in favour of the incumbents, mentioned at S.No. 1, 2 & 3 of para (3) and S.No. 1,3,4,5,7 & 8 of para (6) above respectively.

- 10. The above placement, however, shall not confer any superior claim or right upon them at the time of confirmation which shall be considered strictly as per the Recruitment Rules. The above placement, shall also be subject to the outcome of any writ petition that may be pending in the Court (s) of law.
- 11. The I/C Lecturers shall report to the concerned Directorate of School within 21 days from the date of issuance of this order. If any such lecturer fails to join within the stipulated period of time, it shall be presumed that he/she has foregone his/her placement and his/her placement as I/C Lecturer shall be withdrawn without any further notice.
- 12. The Director School Education, Kashmir/Jammu shall ensure that the PG Masters/Teachers who have obtained their degrees through distance mode during service are verified as per Government Order No. 940-Edu of 2017 dated 17.11.2017 and their P.G. degrees are found genuine.

The Directorate of School Education, Kashmir/Jammu will allow them to join only after verifying the following:-

(i) The bio-data/service particulars of the I/C Lecturers as mentioned above are correct.

If the promotee has already been working either as I/C (ii) Headmaster or I/C Lecturer in other discipline, he may not be allowed to join as I/C Lecturer (English).

The mode of acquiring degree (i.e. 10+2+2 with bridge course or (iii) 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which he/she has acquired such degree are valid.

(iv) The officer is not involved in any adverse case (s) (Vigilance/Crime etc.) which fact shall be ascertained by the concerned Directorate of School Education.

The placement is without prejudice to the outcome of any writ (v) petition pending in any competent court (s) of law or any case pending in Vigilance or Crime Branch.

The Directorate of School Education, Kashmir/Jammu shall ensure that all the above conditions are fulfilled by the official before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the Directorate shall refer the case to the Administrative Department for further course of action.

The concerned Directors after satisfying all conditions mentioned above shall post these I/C Lecturers against the available vacancies preferably in Zone-III and far-flung areas.
