Subject: Nomination of Nodal Officer for coordination & organizing Youth Parliament Competitions- reg.

Reference: O.M No. 3/1/2021-YP dated 14.11.2021 received from Ministry of Parliamentary affairs, GoI.

Sanction is accorded for nominating Project Director Samagra Shiksha J&K as Nodal Officer for coordination & organizing Youth Parliament Competitions annually in JKUT to strengthen roots of democracy, inculcate healthy habit of discipline and tolerance as per following format:

1. (10) ten best schools of JKUT 5 each from, Jammu/Kashmir Division(s) be selected for "Youth Parliament competitions". Out of these Schools, one school from each Division be identified for organizing this event.
2. Mainly students of 10th, 11th & 12th class will participate.
3. Judges for assessing performances at Divisional level will comprise: (i) One eminent leader, (ii) One senior official from District administration, (iii) one Senior Officer from District Judiciary, and (iv) Principal/HoI of the identified School.
4. At UT level competition, two Schools (qualified) will perform before Jury and jury will select the best school for award.
5. The Jury at UT level will comprise:(i) One eminent Political leader, (ii) One senior official from UT level Administration, (iii) one Senior official from UT level Judiciary, and (iv) Principal/HoI of the identified School.
6. Selection of HSS Schools will be done at Directorate level giving representation to all regions at UT level. However, once the school is selected for this purpose, that school will be barred for next 5 years.
7. The cost to be incurred for this purpose by Schools will have upper ceiling of 16000/- per school.
8. By January, every year, details of expenditure will be submitted to Samagra Shiksha by Directorate(s) for reimbursement by GoI through Samagra Shiksha.
