The above placements shall be purely on temporary basis and shall not confer any preferential right upon these officers for their regular promotion against these posts at the time of regularization, which shall be made strictly on the basis of seniority and eligibility in terms of the extant recruitment rules. The above placements shall also be subject to the outcome of writ petition (s), if any, pending any in competent court of law.

The placement of above incumbents shall also be subject to the condition that the claim of the superior for placement, if any, received after issuance of this order shall be considered and junior most incumbent in the placement list shall be reverted back to his/her original substantive post in case the vacancies are not available at the relevant point of time in the discipline of Zoology.

The I/C Lecturers shall report to the concerned Directorate of School Education within 21 days from the date of issuance of this order. If he/she fails to join within the stipulated period of time, it shall be presumed that he/she has foregone his/her placement and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir/Jammu will allow them to join only after verifying the following:-

- The bio-data/service particulars of the concerned promotee official (i) as mentioned above are correct.
- If the official has already been working either as I/C Headmaster or I/C Lecturer in other discipline, he may not be allowed to join (ii) be submitted to as I/C Lecturer (Zoology) and report Administrative Department.
- That the mode of acquiring degree (i.e. 10+2+2 with bridge course (iii) genuineness the as well 10+2+3) Certificates/Institutions from which he/she has acquired such degree are valid, shall be determined and ensured by the concerned Directorate of School Education.
- adverse case The official is not involved in any (iv) (Vigilance/Crime etc.) which fact shall be ascertained by the concerned Directorate of School Education.
- The leaves availed by these official are entered in their service (v) records and is admissible under rules.

The concerned Directorate of School Education, shall ensure that all the above conditions are fulfilled by the official(s) (promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the Directorate shall refer the case to the Administrative Department for further course of action.

The Director, School Education of the respective Division shall after verifying/satisfying all above mentioned conditions, shall post these officials against available vacancies of Lecturers in the respective discipline in the Zone-III and also against the vacancies available in the far flung areas as per the requirements.
