Whereas, the then Headmaster HS Gurdhan Bala, was chargesheeted vide reference No. Edu/Gaz-III/17/2016 dated 31.01.2017, and

Whereas, upon the examination of reply to the Article of Charges submitted by the charged officials/officers, the Government considers that an Inquiry Officer should be appointed to enquire into the charges framed against them.

Now, therefore, in exercise of powers conferred by sub-rule (4) of Rule 33 Civil Services (Classification, Control and Appeal) Rules, 1956, the Government hereby appoints Mr. Pardeep Kumar Sharma, Principal DIET, Rajouri., as Inquiry Officer, to enquire into the charges framed against the Shri Arun Kumar Gupta, I/c Headmaster, H.
